<u>DUES</u> --- Thanks to all who have paid their 2020 dues, purchased donated tickets for the 2020 Steamboat Dinner, and /or donated to the roof replacement. We have only 6 members who have not paid their 2020 dues.

LODGE ROOF----The Trustees and PM Wm. Runyan (his vocation was in the commercial roofing industry including Miller Park) are continuing to gather information and bids on the roof repair and or replacement. WM Ross Chapman will be awaiting the trustees' suggestions regarding the roof with the receipt of the Legacy from June Bay. He would then arrange a conference call or online arrangement so that all the Officers and Trustees can participate and decide what and how to present a proposal to the members (Lodge) for their decision.

STEAMBOAT DINNER---

- The Dining Room was closed for the 2020 SBD to the public because of COVID-19. This decision was made on March 12th prior to the GM suspension of all Masonic meetings and events on March 13th. We thank Br. Kevin DeGuelle and his wife Nikki for being the trigger for our decision to close the dining room to the public. GM Strader allowed us to decide whether to keep the drive-thru open and make Deliveries. We decided to keep the Drive-Thru and Deliveries going.
 - Your team headed by SW Geoff Pinney wasted no time in making appropriate adjustments
 - The Drive-Thru was in **less than 2 hours revamped** to handle an anticipated increase in traffic.
 - By prepackaging all meals using the delivery line set up in the basement.
 - A team was set up to supply the drive-thru with a steady flow of packaged meal from the basement.
 - Persons were added at curbside so 3 vehicles could be served at one time.
 - It worked out beyond expectation. Special thanks to Andy Crow for respectively sharing his ideas.
 - It was awesome to watch this all happen. A virtual reality of Respect, Focus, Friendship, and Brotherly Love in ACTION for a common cause.
- We served 1,225 Dinners.
 - o 766 were **Delivered** Donated Tickets from Washington Island to Denmark.


- o 444 were served from the **Drive-Thru**
- o 15 Workers ate (none of them had vegetables or mashed potatoes as we ran out)
- Twenty-five teams delivered 766 meals in Door (including Washington Island) and Kewaunee Counties.


• Donated Tickets

- The Program began in 1992 with 50 Tickets given to Social Services for their distribution.
- o **In 2020** we had purchased by Lodge members, OES, Friends, and community businesses a record of **863 tickets**, which were 158 more than in 2019.
- The dispersing entities have now grown to 8; DC-ADRC, LSCAP, Sunshine House, DCMC, the Kewaunee Food Pantry-Algoma, Lakeshore ADRC (Kew. County), Washington Island Community Health Program, and JAK's Place.
- Over 75% of the deliveries are done by non-Masonic community volunteers.
- O Since 1992 over **8,800 Donated Tickets** have been purchased and distributed to the eight 501(c)3 entities to be distributed to those in need.
- o 90% are now delivered directly to their homes.
- TRIVIA --- every 6 seconds a packaged dinner came off the packaging line on Saturday of the dinner. DO NOT TELL ANYONE HOW MUCH FUN WE HAD OR HOW MUCH PIZZA WE ATE on our 35-minute break!!!

OVERALL

- o It is a wonderful **outreach** into the community.
- It encompasses, the Lodge, OES, Friends, Businesses, Governmental Agencies, and Non-Profit
 organizations in providing a nutritious meal that can be enjoyed as Pick-Up or Delivered dinner.
 This is a wonderful example of the synergistic effect when all work together in Harmony,
 Friendship and Brotherly Love.
- It is an honor and privileges to work side-by-side with all who make this program a reality. A special thanks to every person who had any part in this event. We work on the LEVEL, act by the PLUMB, and part upon the SQUARE. Thanks to each of you.
- A financial report will be submitted to the Lodge at a later date.
