- Suggestions and Concerns for next year

- Inflation of Food and Packaging Containers. How and when do we set Ticket Prices, the price needs to be set no later than August. The WM plans to set the price by the end of June. We need this time frame so we can start contacting supporters of our Donated Meal program which now accounts for 78% of our revenue.
- We need to establish an easy online purchase of Regular Tickets. We are already working on this. The sale of Regular Tickets has fallen significantly in the past few years.
- We need to continue to search out new 501c3 entities to identify new folks in need for our Donated Meal Program. Businesses are willing to support that growth, the community is willing to make the deliveries and we are able to prepare and package more meals. We have already begun to research possible 501c3 entities.

**<u>DID YOU KNOW?</u>** ---- from "Cathedrals Built by Masons" Russell Herner

- The Original Premier Grand Lodge of England was called the Free and Accepted Masons (F. &. AM) and later named the Moderns.
  - As they began to make changes a disgruntled English group of masons and upset Irish Masons formed a new Grand Lodge in 1751 called the Ancients. It was later named the Ancient Free and Accepted Masons (A.F. & A.M.)
  - The two groups quarreled over ritual and traditions for many years. The ancients wanted to keep the rules and traditions of the old Operative lodges.
  - Finally in 1813 they patched up their differences and united to form the United Grand Lodge of England.
- By 1700 Speculative Masonry had a 2-degree system in place. Entered Apprentice & Fellow of the Craft Master Mason degrees. This was slightly different than the 3-degree system in Operative Masonry; (Entered Apprentice & Fellow of the Craft Master Mason degrees). In1726 in Scotland and later in England the MM degree emerged as a separate degree split off from the Fellow of the Craft Master Mason. Thus, creating our present 3-degree system of EA, FC, and MM degrees
- Operative and early Speculative lodges had no Secretary because no minutes were kept for security reasons.

## **CHARITABLE DONATIONS POLICY**

Henry S. Baird Lodge F&AM #174 (the "Lodge") is committed to supporting causes that improve the quality of life for the residents of the greater Door County area. The Lodge makes donations of cash, goods, or services to local schools, civic groups, and church groups in the communities it serves.

All parties requesting financial support from the Lodge must complete a Charitable Donation Request form. The completed form should fully explain the nature of the contribution being sought and include all requested documentation. The Charitable Donation Request form is available from Lodge members and on its website; all required documentation should be submitted to the Lodge following the directions provided below.

#### **Contributions Policy**

- The organization `must be a 501(c)(3) or non-profit organization.
- Requests should be submitted at least 30 days prior to the event to give proper time to evaluate the request.
- Complete proposals include a description of the organization, its mission and major accomplishments, and a list of current board members and key staff.
- Nonprofit organizations should submit their tax-exempt letters from the Internal Revenue Service with their contribution requests.
- Complete proposals will be considered monthly by the Charitable Donations Committee.
- Incomplete proposals or those with deadlines within 30 days of submission may not be considered.
- The Lodge requires a letter of confirmation of receipt after the gift has been made

#### Preferential consideration is generally given to requests where the following apply:

- The recipient is a local community organization in the greater Door County area.
- Money donated will be spent within the greater Door County area.
- Money donated will directly benefit the residents of the greater Door County area.
- Money donated will benefit a significant group of people (as opposed to a single person).
- The Lodge receives recognition for its donations.

The Lodge does not make charitable donations to for-profit organizations.

In order to accommodate contribution requests, the Lodge may choose to donate promotional items that could be used by the requesting party.
