DONATED STEAMBOAT DINNER TICKETS---Last year we had 563 purchased which was a record. We had a \$2,000 one-time gift from a widow. We have a plan to enable us to reach this number again this year and into the future by reaching out into the community for their support. Following is some talking points that will help you to reach out into businesses or friends that you know in the community, asking for their support. Please talk to your friends and give them the opportunity to support this community program. Personally, my experience in offering this idea to my friends has been very well accepted and appreciated.

Talking Points for Purchase of Donated Tickets for the Saturday March 10, 2018 Steamboat Dinners (SBD)

- <u>HISTORY;---</u>
 - The idea of donating dinners to the needy in Door County **began back in 1992**. We sought the help of Bev. Knutsen and Erin Szalaka from Social Services who partnered with us by identifying those in need of a hot meal.
 - We in turn solicited our members to purchase these special Donated Tickets which were then given to Social Services for their distribution, and the recipients joined us in the basement of the lodge for a hot meal. Their identity remained known only to Social Services. Fifty persons received and used these tickets the first year.
 - Since 1992, the program has expanded greatly and to date 6,600 Donated Tickets have been provided to those in need in the Community. Although, over 75% of these tickets are purchased by Masons and their friends, the program has evolved beyond the Masonic Family with ever increasing support from the Community. A record 563 Donated Tickets were purchased for the 2017 Steamboat Dinner.
