Dear Sisters and Brothers,

On March 14 all meetings and events were suspended due to the Covid19 emergency. IN MEMORIUM

The voice of He Who Doeth All Things Well has called to His Heavenly Home our Past Grand Matron Sister Geneva L. Davis. Our sister was born June 11, 1921, and left us to be with God on March 31, 2020, at 98 years of age. She was a life member and Past Matron of Janesville Chapter, Janesville, and was appointed Grand Marshal by Past Grand Matron Sister Betty Krist and Past Grand Patron Brother John Maher in 1979–80. She was elected Associate Grand Conductress and proceeded through the Grand Chapter line to become Worthy Grand Matron in 1983, serving with Past Grand Patron Brother Jerry Gant at their "Showers of Blessings" session in 1984. Their session was held in the auditorium at the Temple of Freemasonry in Madison.

From her Worthy Grand Matron's report we see the true spirit behind the kind face of our departed sister who said, "We have been showered with so many good things that there is a tendency to take them for granted. It would be well for us to set aside some time each day to give thanks to Almighty God, the giver of every Good and Perfect Gift, for the blessings that are ours. It is good to "Count Our Blessings" and Praise God from whom all blessings flow, and it is well for us to express our thanks to others. I thank all of you. God has given me so many blessings, yet I would ask him to give me one thing more—a thankful heart."

It has been quite a number of years since our sister was able to be present at our Grand Chapter sessions, but she is remembered for her smile and her welcoming voice. She married Cecil L. Davis on July 29, 1938, and was preceded in death by Brother Cecil in 2010. She was also preceded in death by her son John in 2012, two grandsons, David and Joshua, four brothers and one sister. She is survived by her daughter Anita L. Davis (Richard) Markley of Beloit, and her son Cecil R. (Linda) Davis of Janesville; 11 grandchildren, nine great-grandchildren and one great-grandchild.

Private graveside services with burial were held at Milton Lawns Memorial Park. In token of respect, we request that this memorial be read at the first stated meeting after its receipt in each subordinate chapter and that the charter be draped for a period of thirty (30) days.

The Golden Chain of Wisconsin's Past Grand Matrons and Past Grand Patrons has been broken once again with the passing of Past Grand Matron Sister Carla J. Badgley on May 1, 2020. Sister Carla was a member of Wautoma Chapter, Wautoma, and had previously been a member of Waupaca Chapter, Waupaca, where she served several terms as Worthy Matron. She was appointed Grand Warder by Past Grand Matron Sister Joan Smith and Past Grand Patron Brother Ron Pete in 1993. In 1994, she was elected Associate Grand Conductress at the "God Is Glorious" session in Green Bay. She progressed through the Grand Chapter elected line and was installed as Worthy Grand Matron in 1997, serving with Brother Elmer Janka as her Worthy Grand Patron. Unfortunately, after a full year of service to Wisconsin Grand Chapter, our sister was hospitalized at the time of her "Circle of Love" session in 1998 and was unable to preside.

Sister Carla had suffered from Alzheimer's Disease over the past several years and was lovingly cared for by her husband, Brother Don. However, her final days were spent at Angels' Grace Hospice in Oconomowoc and on May 1 she peacefully stopped breathing. She will be greatly missed by her many friends in Milwaukee, Oak Park, San Marino, Waupaca and Dousman. She was a retired teacher and leaves behind many friends from her professional days in the classroom.

She is survived by her husband, Brother Don, her daughter Janet Moran, daughter-in-law, Lydia Badgley, and two grandchildren. She was preceded in death by her son, D. Eugene Badgley who was the soloist at her installation as Worthy Grand Matron in 1997.

There will be a memorial service for Sister Carla after the Corona Virus restrictions are lifted. The service will be held at the Three Pillars Chapel, officiated by Past Andrew Holmes of the Jerusalem Presbyterian Church, assisted by Three Pillars Chaplain Terese Leonhard. The service will include the Eastern Star funeral ceremony; all of these things planned by Sister Carla herself. The family wishes to extend grateful thanks for the many prayers offered during her illness.
